Financial resources and technical support

AGREENFI was designed by AFD Group to encourage financial institutions to offer financial services adapted to support actors in the rural sectors of developing and emerging countries. To this end, AGREENFI facilitates access to financial services and technical support suited to users' needs.

Technical assistance is structured to provide support for both financial institutions and beneficiaries. This support is composed of four components:

Preparing eligible investment portfolios and capacity building of beneficiaries

Strengthening the expertise of financial institutions:

- Training of staff for risk assessment in the rural sector
- Conception of specific financial products
- Implementation of an environmental and social action plans as well as a climate policies

Developing communication tools and support for business developpement:

- Organization of awareness raising and promotional activities
- Digitalization of financial products, management processes and customer services
- Public policy dialogue on financial tools to support the sector

Supporting financial institutions to monitor, report and evaluate the AGREENFI credit line and the technical assistance program
