t the heart of AFD Group research are inequalities and efforts to reduce them, the ecological transition, management of shared resources and economic diagnoses of countries where AFD operates. The results of our research can be of use not only to decisionmakers, but also to the public at large, while also highlighting the pertinence of AFD Group's operational and strategic decisions. To achieve the objectives set by the Group, the research underscores the need to work more closely with stakeholders in developing countries, at both the national and international levels.

Conducted by multi-disciplinary teams, our research allows us to co-design development trajectories with our partners and to identify public policies best suited to the contexts and geographies in question.

This 2021 report lays out the main trends in AFD Group activity in terms of geographical distribution, volume, priority areas, and value-added products. It illustrates the distinct position that research holds in the Group around its five flagship programs.

#### **Just transition in Southeast Asia**

In Southeast Asia, AFD is exploring several facets of the just transition in Lower Mekong countries. These studies focus on issues such as the links between inequalities and environmental degradation, and between social protection and environmental challenges. They are based on systematic reviews of the literature and all advocate for the need to include the economic, social and environmental dimension in analyses and an integrated approach across regions and disciplines, as well as the construction of common socio-ecological systems at various levels.

## Supporting research in developing countries

he expertise and innovation produced locally enable us to address the specific sustainable development issues of the countries concerned as closely as possible and contribute to defining their public policies. Nevertheless, research is underfunded in most of the countries where we operate. Researchers and research spaces exist, but they are generally isolated, not very visible, and not well connected to the public debate and decision-makers.

is the financial equivalent of studies and research contracted by AFD with the involvement of at least one partner from the region concerned With this in mind, **AFD Group is now** focusing on supporting national research, and consolidating networks of researchers in developing countries, in line with its objective of increasing research partnerships and carrying out projects that strengthen and promote research capacities in the countries where it operates.

## AFD Group supports and assists research in developing countries in various ways:

- by systematically involving local teams in the research that it finances in a given country
- by financing projects to reinforce research capacities in developing countries
- by supporting numerous initiatives to assist young researchers in developing countries
- by producing knowledge on research in developing countries through publications or events

#### Support for strengthening research capacities in developing countries

The Clermont-Ferrand International Development Hub (PCDI) project supported by AFD comprises a component dedicated to supporting research in developing countries, led by the Global Development Network. It is helping partners in five African countries to produce and promote knowledge on sustainable development issues, while building the capacities of researchers and research institutes: media training, writing workshops, doctoral schools and institutional capacity building.

#### Public Development Banks: Key actors in sustainable finance

Responsible for 10% of global investment, Public Development Banks (PDBs) have a major role to play in the achievement of the Sustainable Development Goals (SDGs). With the Institute of New Structural Economics (Peking University), AFD has jointly built a database of 527 PDBs, together with five thematic studies highlighting the crosscutting nature of these banks. With the SDG Prospector, AFD also explores the use of artificial intelligence to map the alignment of PDBs with the 2030 Agenda.

# Flagship projects in 2021

#### Biodiversity & financial risks



The study "A Silent Spring for the Financial System?" provides an analytical framework to understand the risks that biodiversity loss poses to the French financial system. It thereby opens up a field of research on the inclusion of biodiversity in development trajectories.

#### **Debt sustainability**

Debt reaccumulation in African countries over the last decade has been coupled with a transformation of their debt profile and a diversification of their external creditors. An analysis of these trends provides insight into the gradual deterioration of the sustainability of public debt in Africa.



#### Inequalities



The Research Facility on Inequalities is assisting the Colombian government with the implementation of effective public policies by working on inequality diagnostics and fiscal incidence assessments.

#### ESTEEM

The ESTEEM tool analyses the macro-structural vulnerabilities that could emerge in developing countries as they embark on their transition to low carbon economies.

#### Strong sustainability and public policies

AFD conducts its trajectory analyses from the perspective of strong sustainability, recognizing interlinkages between the preservation of the integrity of ecosystems, the reduction of inequalities and prosperity. These analyses are made using various tools (including GEMMES, ESGAP and fiscal incidence assessments) and inform public policy options compatible with the 2030 Agenda.

# Just transition in South Africa

AFD and the European Union, in coordination with the Office of the President in South Africa, have launched a research program to assist with the development of public policies and their implementation at the national and municipal levels. The objective is to promote linkages between infrastructure-led and job-creating growth and initiatives that bring about a transition respectful of social and environmental balances.

AFD Group's studies and research results are disseminated in a variety of ways: organizing conferences and webinars, and numerous publications for both expert and lay audiences.

#### Conference on financing African research
