The Global Gateway strategy and the #TeamEurope approach are cornerstones

of this commitment, which is being deployed throughout the world.

France plays a central role in conjunction with AFD Group. Alongside the European Commission, we have been participating in the European solidarity investment policy since 2008 through joint dialog with countries and increasing co-financing.

Team Europe is also present on a daily basis in our numerous partnerships with our bilateral European contacts. The Joint

European Financiers for International Cooperation (JEFIC) – Europe's network of international public development banks - has enabled AFD and its German. Spanish, Italian, and Polish counterparts to mobilize almost €21 billion by 2022. Proparco represents our Group in the European Development Finance Institutions (EDFI) network, while Expertise France has chaired the Practioner's Network (PN) since 2023, making AFD Group the only European organization represented in all three #TeamEurope networks.

Since 2008, we have been participating in Europe's solidarity investment policy through joint dialog with countries and increasing co-financing.

In addition to reaffirming mutual trust within the European community, these networks give us new visibility and greater effectiveness in the field. This is illustrated by the Team Europe Investing in Young Businesses in Africa (IYBA) initiative, through which our three organizations support young African entrepreneurs, or the City Investments to Innovate, Integrate and Sustain (CITIIS) program, launched in 2012 by AFD and the European



Commission to promote the sustainable development of Indian cities, and strengthened with German support from KfW, our leading bilateral partner.

AFD Group, in conjunction with the European Commission, the European Investment Bank (EIB), the European Bank for Reconstruction and Development (EBRD), and all the development institutions of the Member States of the European Union, represents a unique platform for exchange. This facilitates experience sharing with all our partners around the world to achieve the Sustainable Development Goals and carbon neutrality.

Together, let's continue to build a Europe of solutions for sustainable development and international partnerships based on respect, modesty, and determination.

275 projects supporting the SDGs

riven by shared convictions, AFD Group and the European Union are working hand in hand to enhance the impact of their financing in the field and the effectiveness of development aid. Their cooperation has grown stronger over time, through ongoing dialog, by producing joint studies that contribute to the European debate, and by co-financing joint initiatives.

A key partnership

AFD has been approved to manage European funds since 2008. From 2014 to 2022, it has benefited from over €3 billion in European resources, supporting the co-financing of 275 projects in 74 countries. This figure rises to some 350 projects if we include those managed by Expertise France and Proparco, AFD Group's two other organizations.

AFD Group's partnership with the European Commission covers a wide variety of sectors. At the top of the list is the energy sector, followed by agriculture, biodiversity, and sustainable development, which account for over 40% of funding. In addition, AFD is the only financial institution to be involved in certain mixed facilities in the health, education, and agriculture sectors.

Today, AFD Group is mobilizing to meet the challenges of the 2021-2027 European programming and to add a more strategic dimension to its partnership with the European Union.

AFD Group is a driving force behind Team Europe. AFD, **Expertise France, and Proparco** are at the forefront of demonstrating the added value and know-how of member states in implementing the European agenda.

AFD Group's investment in a large number of Team Europe initiatives, as well as its participation in the various networks that make up the European aid architecture, are essential. Cooperating with AFD Group means rallying around shared priorities and working together towards common goals. We also offer quality solutions to our partner countries, in line with the Sustainable Development Goals and the strategic interests of the European Union.

AFD Group has a role to play in strengthening **European networks** and implementing **European** external initiatives.

Do you have any particular expectations for the Group?

Bringing Expertise France into AFD Group makes it even more responsive to our partners' needs. We are following this dynamic with interest, as the Team France format mirrors the Team Europe approach for greater visibility on the international stage against a backdrop of heightened geopolitical competition. This Team Europe approach reflects our ambition to work together more effectively - by better coordinating our actions

and pooling our efforts - in order to increase the impact and effectiveness of our efforts in partner countries.

AFD Group has a role to play in strengthening European networks - the European Development Finance Institutions (EDFI) network, the Joint European **Financiers for International** Cooperation (JEFIC), and the Practitioner's Network (PN) - but also more generally in implementing European external action.

The private sector will also play a decisive role in meeting the numerous challenges of sustainable development. I'm counting on AFD Group to continue pushing forward and encouraging work in the European format, mobilizing European development finance institutions and building bridges with businesses, which are key assets in achieving our objectives.



How do you view the co-financing agreement signed with JEFIC in March 2023?

This agreement was signed under the auspices of the European Commission, between AFD, KfW, the Italian Cassa Depositi e Prestiti (CDP), and the Spanish Agency for Development Cooperation (AECID). The European Commission views this agreement as a positive step towards forging closer ties between European funding agencies for international cooperation. This enhanced cooperation is in line with the Team Europe approach we are promoting, and will facilitate the implementation of the Global Gateway strategy (see box on right). This kind of initiative, aimed at working more closely together, brings us closer to our goal of being more effective in the field and more visible to our partners in the European format.

Launched in 2022, the European Global Gateway strategy aims to tackle the world's most pressing challenges, from climate and healthcare to transport and the need to secure global supply chains. It will mobilize up to €300 billion by 2027. These investments will focus on sustainable projects, taking into account partner countries' needs and the interests of the European Union and its member states.

Through its participation in Team Europe initiatives and a number of flagship Global Gateway projects, AFD Group is helping to unite European cooperation around projects with a high transformational impact. "Coordination between the Group's three organizations is crucial," underscored Koen Doens. "Backed by its range of tools and multi-sector expertise, AFD Group helps stimulate investment and attract the private sector to our partner countries while offering technical assistance to support these dynamics." This is the model the European Union wants to offer its partners: a "360-degree" solution integrating financing tools (loans, grants, and guarantees) and support measures (technical assistance, promoting high social and environmental standards, etc.).



Energy For an accessible, efficient low-carbon energy supply

early 800 million people worldwide have no access to electricity, 600 million of of whom are in sub-Saharan Africa. For cooking and heating, 2.8 billion people rely on traditional fuels like firewood, which frequently puts families at risk of smoke inhalation. This situation hampers economic competitiveness, slows down the development of countries, and limits access to healthcare and education. The energy transition is an economic, social, and environmental opportunity.

Encouraging the energy transition

To promote this transition and increase access to reliable, clean, low-carbon energy services, AFD Group supports renewable energy sectors in developing countries. This

Access to energy is a crucial issue when it comes to economic competitiveness, education, healthcare, etc. commitment is shared by the European Union. The two projects presented here illustrate these shared ambitions. The ARE Scale-up funding facility, created in 2016, aims to accelerate the development of renewable energies across Africa. In Mozambique, the PROLER program, underway since 2018, is set to deploy a total capacity of around 120 megawatts of electricity by 2024.

If renewable energies are to be scaled up in Africa, there are many obstacles to overcome, such as outdated grids, inadequate regulatory frameworks and a lack of expertise. The ARE Scale-up facility, launched by AFD Group and the European Commission in 2016, helps fulfill France's commitment to support the development of renewable energy sources in Africa to the tune of €2 billion.

Access to the power grid has tripled in Mozambigue in recent years, rising from 8% in 2006 to 31% in 2019. Demand for electricity is expected to grow by 7-8% each year, driven by a government policy aiming for universal access by 2030. To support this process, AFD is backing the PROLER program, which aims to develop the country's power generation from renewable energy sources. PROLER is set to deploy a total capacity of around 120 megawatts, divided into four distinct infrastructures: three solar photovoltaic projects are planned in the north of the country; a fourth site has been selected for deploying a wind power project.

Preserving biodiversity and the environment

estruction of natural environments linked to changes in land and sea use, overexploitation and extinction of species, climate change, pollution: these are just some of the multiple pressures on biodiversity. And their impact on populations and economies is unprecedented. Protecting biodiversity is a key part of AFD Group's strategy. The projects funded in this area aim to halt the loss of biodiversity, protect ecosystems, and support the restoration and management of natural areas, with and for the benefit of local communities.

A cross-cutting strategic marker

Every project funded by the Group is now assessed in terms of its impact on biodiversity. By 2022, the Group had committed €736 million to directly or indirectly preserve biodiversity in developing countries and the French overseas departments. Biodiversity is also one of the stra-

These projects target a wide range of objectives, including the development of a network of educational organic farms to improve food security,

planning and implementation of ecosystem-based adaptation on a territorial scale, integrated watershed management, conservation and restoration of mangroves and coral reefs to combat natural disasters, reducing invasive alien species and community-based fisheries management. They also help to promote gender equality, human rights, and social inclusion.

South of Cairo, the Helwan wastewater treatment plant collects wastewater from 1.6 million inhabitants. Since 2021, the joint work of AFD and the European Union, in close collaboration with the Egyptian Construction Authority for Potable Water and Wastewater (CAPW), has enabled this wastewater treatment plant to be equipped with a comprehensive water resources management system. It will provide a reliable, high-quality wastewater service in the south of the city, reduce wastewater-related pollution in the AI Saff irrigation canal, and promote growth in line with the challenges of climate change.

The project also includes biodigesters to recover part of the sewage sludge produced, optimize the plant's energy and financial balance, and reduce its carbon footprint. In addition, two new pumping stations will be built, the irrigation canal receiving treated wastewater will be renovated, and technical assistance, project management, and auditing services will be provided.

AFD Group is a key historical partner of the European Union in the neighborhood and enlargement regions. In the field, I am aware of the importance of AFD's network of local agencies and the quality of the public policy dialogs with our partner countries.

I also value the excellent cooperation we enjoy as part of our Team Europe initiatives (see box on right) and our close links with the European Union delegations. This cooperation covers priority sectors such as environmental transitions, infrastructure, energy, water, and food safety.

How do you work with DG NEAR?

AFD, Proparco, and Expertise France contribute to the implementation of our economic

and investment plans (EIP) and their flagship projects in the Western Balkans and the countries of the Eastern and Southern Neighborhood. The aim is to support post-Covid-19 economic and social recovery in these three regions and contribute to the implementation of the Global Gateway (see page 7).

And as part of EFSD+, the European Fund for Sustainable **Development Plus?**

By way of example, DG NEAR has allocated coverage of €100 million – combined with €76 million from the Directorate General for International Partnerships (DG INTPA) - to the FAST Cities program proposal. By involving the private sector, this project is helping to develop sustainable investments in cities in a number of areas: urban infrastructure, waste management, water and sanitation, housing, and transportation. We are counting on AFD Group to



speed up implementation of this ambitious program and achieve its objectives.

How do you see the partnership between DG NEAR and AFD Group in the coming vears?

Budgetary guarantees have become a well-established instrument for the European Union. Our partnership will be further expanded in this area. We want to increase the leverage of our resources and mobilize the private sector to support climate, environmental, digital, and social transitions.



Finally, we are aware of, and follow with interest AFD Group's strong investment in mobilizing other development actors and banks – both public and private. This activity ranges from aligning different agendas to the mobilization of financial resources for climate, development, biodiversity, and achieving the Sustainable Development Goals (SDGs). As such, we support AFD's efforts in platforms and forums such as the Finance in Common (FiC) summit, the Joint European Financiers for International Cooperation (JEFIC), and many others.

We follow with interest AFD Group's strong investment in mobilizing other development actors and banks - both public and private.

With this in mind, AFD Group is forging alliances with bilateral European partners. Through AFD, the Group is a member of the Joint European Financiers for International Cooperation (JEFIC), a network of European bilateral public development institutions. Through its subsidiary Expertise France, the Group is also represented in the Practitioners' Network, which includes European technical cooperation agencies. Finally, via its subsidiary Proparco, AFD participates in the European Development Finance Institutions (EDFI) network of private-sector institutions.

Cities in the European neighborhood will be the focus of the FAST Cities program. This program contributes to the development of sustainable investments in urban infrastructure, waste management, water and sanitation, housing, and transportation

A partnership approach to achieve the SDGs

Achieving the 2030 Agenda requires greater convergence of financial flows towards the SDGs and, to this end, the collective mobilization of cooperation and development stakeholders.

At the same time, AFD Group is building ties with multilateral partners such as the European Investment Bank (EIB), the European Bank for Reconstruction and Development (EBRD), and the Council of Europe Development Bank (CEB).

A "strategy of influence" via mobilized networks enhances the role and weight of national institutions in the European aid structure, and helps make aid more effective and relevant for our partners in the field.



FD Group and the European Union are committed to working on the structural causes of crises in order to prevent or contain them. The Group combines rapid response with long-term adaptability. When the violence is too great, it supports the resilience of those affected, contributing to humanitarian operations. More than anywhere else, we are committed to a collaborative approach, particularly with our European partners.

Laying the foundations for sustainable development

In prolonged socio-political crises, the Covid-19 pandemic was an additional destabilizing factor, with increased social unrest, the loss of confidence in public authorities, and vulnerable populations particularly affected by border closures and confinements. Faced with this emergency, AFD Group mobilized its resources and endeavored to adapt its operations.

Two projects funded by the Minka Peace and Resilience Fund illustrate the close partnership between AFD Group and the European Union in crisis zones. The Resilience and Social Cohesion Program, shown opposite, demonstrates the operational flexibility deployed to combat the Covid-19 pandemic in the Near and Middle East. The RESILAC ("Inclusive Economic and Social Recovery of Lake Chad") regional project is also an emblematic intervention: in an area affected by the Boko Haram crisis, it responds to the immediate needs of local communities, while at the same time taking structuring action to target the root causes of their vulnerability.

Greater social cohesion

Through the Social Cohesion and Resilience Program – funded by the European Union's Madad Fund and implemented in Lebanon, Jordan, and Irag – AFD and its partners have demonstrated their ability to adapt to the devastating effects of Covid-19 on Syrian refugees and host communities. The actions planned in the healthcare sector have been rethought to raise awareness of the health risks associated with the virus, to adapt the psychosocial messages disseminated during awareness campaigns, and to develop new psychosocial support methods so as not to break social links.

These actions linked to the Covid-19 pandemic were carried out as part of a wider intervention to improve Syrian refugees' access to basic services – and in particular to healthcare services, including mental health – while promoting social cohesion between communities. AFD's four NGO partners worked in close collaboration with national institutions and civil society organizations.

Towards an inclusive socio-economic recovery in Lake Chad

Funding: €36 M of which €31 M EU grants delegated to AFD Recipients: Action Against Hunger in consortium with CARE International and Groupe URD Timeframe: 2018-2022

The Inclusive Economic and Social Recovery of Lake Chad (RESILAC) regional project supports economic recovery and improves resilience and social cohesion in the four countries surrounding the Lake Chad Basin (Cameroon, Niger, Nigeria, and Chad). The actions carried out covered 13 territories and 254 villages. To consolidate the project's achievements and scale up promising actions, AFD and the European Union have agreed on a second phase for 2022-2027.

Through a comprehensive approach supporting displaced populations, returnees, refugees, and vulnerable host communities, the project creates an environment conducive to economic recovery,

resilience, and social cohesion, while taking climate change into account. It helps improve access to basic services, livelihoods, and opportunities for social inclusion. Local authorities and organizations are also supported, particularly to ensure the peaceful management of natural resources. The project's mental and psychosocial support activities and integrated learning and knowledge management system make it particularly well-suited to the local context.

Mobilizing a Group

AFD Group has two subsidiaries: Expertise France, the interministerial agency for international technical cooperation which joined the Group in January 2022 - and Proparco, a subsidiary dedicated to private sector financing. Both contribute to AFD Group's European partnership.

Supporting Moldova's economy amid the war in Ukraine

One year after granting an €8 million loan to Microinvest, Proparco renewed its support for Moldova's leading microfinance institution in June 2023, via a €10 million credit line backed by the European Union's EFSD-MSME quarantee.

Originally set up by the Soros Foundation, Microinvest has expanded by targeting the agricultural sector. This new commitment from Proparco will particularly benefit micro-entrepreneurs and smallscale farmers. Hard hit by the drought of 2020, these farmers are now having to cope with the consequences of the war in Ukraine. Proparco's financing is thus part of a highly strategic response, reinforced by Moldova's request to join the European Union in 2022.

ince 2014, AFD Group has been committed to mobilizing more delegated funds from the European Union on health issues. The objectives are to encourage access to quality healthcare, particularly for the poorest and most vulnerable people, promote sexual and reproductive health, work towards universal healthcare coverage, and strengthen healthcare and social protection systems in the face of climate change.

The challenges of climate change

The climate is a major health issue, with the rising incidence of climate-sensitive diseases and the emergence of new infectious diseases. These impacts require us to support healthcare systems and improve their resilience. The challenge is twofold: firstly, to reduce the sector's greenhouse gas emissions, and secondly, to adapt services to the effects of climate change.

Climatesensitive diseases, or new infectious diseases... Climate is a major health issue. The European Union and AFD Group are working to promote health for everyone by supporting structuring policies and programs. Two projects in particular illustrate this shared commitment: in Turkey, the construction and equipping of a hospital that proved its worth in the aftermath of the February 2023 earthquake; in Senegal, the government-led reform of the pharmaceutical

sector with the aim of meeting 50% of the country's healthcare product needs by 2050. Working together to improve access to healthcare

Inequalities in access to Covid-19 vaccines worldwide have made it essential to strengthen pharmaceutical sovereignty in Africa. Alongside its European partners, AFD supports the strategy of the African Union and the African Center for Disease Control and Prevention (CDC Africa) to build regional vaccine production platforms by reinforcing local industries and their ecosystems.

In Senegal, for example, AFD is supporting the government in implementing its plan to revive the pharmaceutical sector. The aim is to meet 50% of the country's healthcare product needs by 2050. This support aims to promote a structuring approach. It is provided *via* a public policy

loan as part of a Team Europe initiative dedicated to the production of healthcare products.

From 2017 to 2022, AFD appraised the project to build and equip a public hospital in Dörtyol on behalf of the European Union. The project was funded as part of the Refugee Facility for Turkey (FRiT), launched in 2016 to support Turkey's efforts in hosting more than four million Syrian refugees.

In this main town of the Hatay state, where more than 500,000 refugees have been welcomed for a population of 1.5 million, this new facility, inaugurated in 2022, has doubled the local hospitalization

capacity to 300 beds. The hospital also facilitates access to specialized healthcare for refugees and host populations.

High anti-seismic standards, in line with European standards, have enabled the hospital to withstand the February 2023 earthquake and meet the population's needs during this crisis.

S

ince 2015, AFD and the European Union have made it a priority to combat inequality. The European Commission and AFD began their collaboration on this topic in 2017 with the establishment of the EU-AFD Research

Facility on Inequalities. Funded by the European Union and coordinated by AFD, this facility helps to improve knowledge of socio-economic inequalities and to develop the most appropriate strategies for reducing them. In this way, it is helping to achieve the Sustainable Development Goals (SDGs), and more specifically combating inequalities (SDG 10).



Between 2017 and 2020, 23 research projects were conducted in 32 countries. They have provided a better understanding of socio-economic inequalities, their determining factors, effects and dynamics, and have led to the publication of one hundred research articles. This program

has also fueled academic debate and initiated or intensified national exchanges on the theme of inequalities in the countries involved. A research facility to better understand inequalities

Strengthened partnerships between countries

The success of this program led to the launch of a second phase in 2021. This extension supports defining policies to reduce inequalities in four partner countries: South Africa, Mexico, Colombia, and Indonesia. In the long term, it will enable partner countries and development stakeholders to better understand the dynamics of inequalities and respond to them through more inclusive, equitable public policies and strategies.

This research facility also plays a role in building a common European strategy to reduce inequalities. Through its Strategic Committee, it reinforces cohesion between EU member states and supports the European Commission in implementing this objective.

An assessment tool in three test countries

This research project furthers the analysis of inequalities and public debate on strategies to reduce them. To this end, it is developing a test assessment tool to be implemented in a limited number of pilot countries: South Africa, Kenya, and Ghana. This tool provides an in-depth analysis of multi-dimensional inequalities in a given country. The conclusions drawn from this analysis help governments to identify priorities and policy options for reducing inequalities.

Promoting more egalitarian public policies in Colombia

The second phase of the facility supports the Colombian government in setting up a public policy program to reduce inequalities. To date, an assessment of inequalities has been conducted, along with a study of the redistributive effects of fiscal and social policy.

This first stage of the program revealed that territorial and land inequalities are the most significant ones in Colombia. It also shows that fiscal and social policies have a significant impact on inequalities, notably through social transfers, retirement pensions, and indirect taxes. Based on this, the cornerstones for future public policy will take environmental sustainability into account. They must also address social and fiscal issues, reduce territorial inequalities, and provide for comprehensive rural reform.

Equitable economic diversification in South Africa

South Africa remains a highly unequal country in terms of wealth distribution, living standards, employment opportunities, and household incomes. The two pillars of phase 2 of the Research Facility support South Africa's Economic Recovery and Reconstruction Plan. The first pillar consists of developing an online tool to provide detailed information on the local labor market and skills to help public authorities, from national to local level, to develop equitable economic diversification strategies, especially in a coal phase-out scenario.

How can funding instruments support this evolution and contribute to greater impact in the field?

Funding tools are continuing to evolve, guided by a greater focus on the needs of project recipients. They are also moving towards greater simplicity in order to work more effectively and attract more private sector investment.

In this sense, the co-financing agreement signed in March 2023 within the Joint European **Financiers for International** Cooperation (JEFIC) takes things further. Recognizing each other's expertise encourages funding for joint projects carried out by the appropriate stakeholders in a context of greater trust.

It is by pursuing this path that the architecture of European aid can truly support Europe's geopolitical assertiveness on the international stage.
