EVALUATION TYPES

Project evaluations (or clusters of project evaluations) feed into dialogue with stakeholders on results, thereby fostering mutual learning.

Broad-scope evaluations focus on a theme, a sector, a geographic area, or a financial instrument as a whole.

Impact evaluations measure the effects of an intervention on the populations or ecosystems concerned—whether intended or unintended—and analyze the mechanisms that led to the observed changes, as well as the extent to which the project contributed to them. Their findings help inform research on official development assistance.

Capitalizations are based on evaluation findings, analytical reviews, and practitioner experience. They prioritize actions with a collective dimension, across multiple projects.

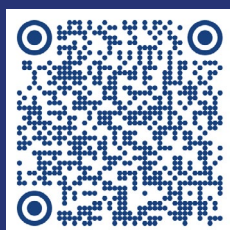
