AFD Group's energy transition strategy

Supporting the energy transition towards universal access to efficient, decarbonized and affordable energy services.

A successful energy transition requires ambitious public policies, major investments, and active private sector engagement. AFD Group gears its action towards the specific needs of each country and stakeholders, with three key focus areas and three cross-cutting levers for acceleration.

THE 3 FOCUS AREAS OF AFD GROUP'S WORK FOR THE ENERGY TRANSITION

ACCESS TO ENERGY SERVICES FOR ALL

- Provide solutions ranging from grid densification to the deployment of off-grid extension
- Support sustainable supply chains for household and light industry fuels

ENERGY EFFICIENCY AND DEMAND MANAGEMENT

- Integrate demand management into energy policies
- Consider energy efficiency in all sectors

A MODERNISED AND LOW-CARBON ENERGY SUPPLY

- Support the deployment of renewable energies
- Reinforce and extend power grids
- Strengthen supply chains, from critical minerals to low-carbon technologies



Financing a rural electrification project (RIMDIR Énergie) in Mauritania €24 M grant (AFD and EU)

Objective

Deploy seven mini-grids to connect 47 rural villages in southeast Mauritania, with support from AFD and partners.

Result

Almost 40,000 people and 700 economic activities will benefit from 90% solar-powered electricity through the first public-private energy partnership in Mauritania.



Program for Energy Efficiency in Buildings in Mexico (PEEB Cool) \$100 M Ioan and €1.5 M grant

Objective

Support the low-carbon transition through the construction of climate-resilient buildings.

Resources

Green credit line to the Mexican Public Development Bank NAFIN to finance energy-efficient and sustainable building projects.



Financing the Nachtigal hydropower project in Cameroon Loans for a total of €150 M (AFD and Proparco)

Objective

Increase Cameroon's power generation capacity by 30%, while providing climate co-benefits.

Result

Commissioning of a 420 MW hydropower plant near Yaoundé in 2025.

SUPPORT ENERGY-TRANSITION POLICIES

- Assist with modelling and planning the transition, and with the implementation of sectoral reforms

The Just Energy Transition Partnership (JETP) in Indonesia €500 M of financing: loans and technical assistance (AFD, Expertise France, EU)

Objective

Support the just energy transition in Indonesia.

Resources

A development policy loan to support energy sectoral reforms and a Result Based Loan to PLN, with disbursement indicators linked to renewable energies and grids investments.

- Assist energy companies and industries in implementing their decarbonization trajectories
- Strengthen the technical, organizational and human capacities of power utilities

Support for the decarbonization of OCP* in Morocco €350 M transformational loan (AFD)

Objective

Support OCP's transition strategy, focusing on decarbonization and sustainable development.

Resources

A €350 M loan, linked to strategic indicators, in four key areas: renewable energies, green hydrogen, sustainable water management, and the integration of climate and biodiversity issues.

Digital Energy Supporting the digital transformation of the energy sector (AFD)

Objective

Support the digital transformation of the energy sector to improve operators' performance and facilitate access to energy.

Result

Financing for more than 40 innovative start-ups (private and public) in four years in Africa, as well as training and exchanges to build the capacities of energy operators.

A comprehensive offer addressing multi-sectoral issues

The energy transition applies to all economic sectors and is based on measures ranging from demand side management and energy efficiency to the decarbonization of energy uses. It requires a massive increase in investment in the energy transition of emerging and developing countries. Energy transition policies also need to maximize their socio-economic impacts at local level, in job creation for example.

DEPLOYMENT OF THE GROUP OFFER FOR THE ENERGY TRANSITION OF UZBEKISTAN

More than €470 M of financing.

Public sector action

"Energy-Climate" budget financing from **AFD** to support Uzbekistan's power sector reforms towards a low-carbon economy, and financing for projects to reinforce the electricity grid.

Expertise France is assisting the Ministry of Energy and Ministry of Economy with the implementation of AFD's "Energy-Climate" budget financing. The program aims to integrate the social impact of price increases, improve energy efficiency, upgrade the grid, and explore innovative solutions such as agrivoltaics and biomass.

Private sector action

Proparco is financing three wind farms and two solar power plants in Uzbekistan, including the country's largest energy storage system (BESS – 500 MWh), with a total renewable generation capacity of 1.3 GW.

AFD Group's offer is thus supporting a sustainable energy transition in Uzbekistan that benefits its population, with an estimated impact of **2.8 million tons of CO**₂-equivalent avoided per year.

PARTNERSHIP WITH THE PHILANTHROPIC ASSOCIATION GLOBAL ENERGY ALLIANCE FOR PEOPLE AND PLANET (GEAPP)

Objective

Promote universal access to energy and support a just energy transition in Africa, Asia, Latin America and the Caribbean.

Resources

Identification of co-financing opportunities and development of programs for the energy transition.

SOUTHEAST ASIA ENERGY TRANSITION PARTNERSHIP (SEA-ETP)

Objective

Accelerate the energy transition in Southeast Asia through a platform gathering public donors and philanthropic partners. This partnership supports studies and projects in Indonesia, the Philippines and Vietnam, while facilitating the sharing of regional knowledge.

Result

In four years, SEA-ETP has become a major player in the region. It is especially active in supporting the implementation of Just Energy Transition Partnerships (JETPs) in Indonesia and Vietnam.

Objective

Facilitate the sharing of French expertise in the energy transition with our partner countries.

Resources
